CONFERENCE SPORTS

SCHOOL REP & SCHOOL MEMBERSHIP LIST

The School Rep should be elected by the staff. The School Rep then becomes the link between the members at the school and the Branch / HQ. The school rep is the live wire at the school level, ensuring all Union Literature is distributed in time, assist members with all Forms and attend to all Branch meetings, etc.

SELF FUNDING MEDICAL PLAN

This initiative was approved by the 2011 AGM in Rewa. It is indeed pleasing to report that the Scheme is doing extremely well. All the members and their families who needed treatment have been assisted and the fund enjoys a strong surplus. As predicted, the benefits are going to be increased incrementally.

Please be reminded that there is no refund for levy paid for the Medical Plan. Those who need assistance, get assisted and those who do not become sick, are blessed. It is a scheme where members contribute to get assistance and to assist others in times of need.

PUBLICITY MATTERS

The February issue of the Newsletter was sent to all the School Reps in the first week. Branches must keep their membership informed of current issues by sending regular Branch Newsletters. Branch Secretaries are advised to send a copy of their Branch Newsletters to HQ. The 2016 Year Planner was also sent to the Branches in early February for distribution to the members. If you have not received the Year Planner then get in touch with your Branch Executives. The Conference Journal is presently being put into shape and the Publicity Committee is requesting members to contribute articles towards the Journal.

The theme for the 86th AGM is "Reclaiming the Rights of Teachers". The Publicity Committee has the right to select and edit the articles which will be submitted.

LABOUR DAY CELEBRATIONS

International Worker's Day was celebrated on May 2nd before the National Executive Meeting with a cake cutting ceremony. The National President alluded to the fact that the significance of Labour Day has considerably diminished in Fiji. However, FTU believes that concerted efforts must be put in to restore workers lost rights, especially the right to seek redress and the right to grievance procedures. During the celebration, FTU called upon all employers to ensure that the rights of workers are respected and fully restored and that they engage with Unions in collective bargaining in good faith. Members must be aware that FTU had submitted a Log of Claims to the Education Ministry. FTU also notes with concern that the Public Service Disciplinary Tribunal has not been functional for more than 12 months although there are several cases pending for long and need to be addressed.

ENTRY POINT SALARY

Members would recall that the Ministry of Education had put all new recruits in 2015 on a \$12,361.00 salary. The Union strongly objected to this act of exploitation. The salary scales of 2015 recruits were corrected in 2016. The 2016 recruits were once again lumped together at the certificate salary of \$16,600.00. This matter is being pursued through the dispute mechanism.

RIGHT OF REPRESENTATION

Members are to note that if you are called to appear before the MoE disciplinary committee, you have the **full right to be represented**. Please notify the Union and you will be assisted/represented.

Also note that for any disciplinary case, MoE must give you ample notice in writing as to what the offence charged is/are.

Members have complained that they are being informed via phone to appear before the Disciplinary Committee and that only a days notice is given. This is in breach of Natural Justice and the Right of Representation.

The Union has written to the Attorney General's office, requesting that Public service disciplinary tribunal be set up as soon as possible. The request has been referred to the honorable Chief Justice for his consideration and necessary action.
