The theme is based on Sustainable Development Goal 4. There are 17 S.D.G's which some 180 countries including Fiji have committed to achieve by 2030. The S.D.Gs' target is accomplishing the unfinished work of the M.D.G's. Education has been prioritized as 4th in the list and a meeting of the Education Ministers in Incheon, Korea clearly spelt out the targets to be achieved.

Partnership & Inclusivity are strongly emphasized. Governments have committed to involve teacher organizations at all levels of planning, implementation, monitoring and review of the policies till 2030.

#### **INDUSTRIAL RELATIONS**

#### 1. Job Evaluation

The aims of the JEE are:

- a) Define Position Based Pay
- b) Confirm that remuneration is based on the requirements of the position.
- c) Ensure consistency in the remuneration of staff across the Fijian Civil Service.

The exercise will be carried out by a New Zealand consultancy firm, in partnership with Price Water House. Consultants will meet with the Unions and receive submissions.

Confederation of Public Sector unions (CPSU) is meeting with the Minister for Economy to ensure the process involves the Unions as workers reps.

#### 2. Discipline Guide

The Civil Service Reform Management Unit is formulating a Guideline for all the Permanent Secretaries. The Guideline's objective is to ensure the Permanent Secretaries apply their constitutional responsibilities fairly, consistently and equitably.

#### 3. Teachers' salary

It has been brought to our notice that Diploma holders are put on \$16,610 salary. The Union has written to the PS to correct it as \$16,610 p.a salary was for Certificate holders. The entry point for Diploma holders is \$18,056, Bed and BA GCED is \$23,411 and degree without Teacher training is \$21,438. We will pursue till members get their just salary.

### 4. MOE Disciplinary Staff Board Disbanded

The Union had submitted to the Ministry much earlier that the DSB was not constituted correctly, and was void of natural justice. However, MOE continued despite with the process correspondences. Union was compelled to raise the matter with the Minister for Public Service, Hon. Aiyaz Sayed Khaiyum who directed that the DSB be disbanded because it was unconstitutional. He further invited all the aggrieved teachers to submit their cases to his Ministry to be reviewed. The Union has made it clear that the decisions of the illegitimate DSB must be reversed with no loss of benefits.

All disciplinary cases are now being dealt with by the Public Service Disciplinary Tribunal.

#### 5. Tribunal

Aggrieved members have taken individual grievances to the Employment Tribunal. Two rulings have been made in favor of the members. A few cases are still with the Tribunal and decisions are expected soon. Members are reminded as per ERP, they can take their grievances to Mediation & Employment Tribunal.

The Union has filed a case in the Arbitration Court seeking justice for those teachers who were employed on \$12,360 salary 2015.

The Union has submitted that these Teachers had fully met the requirements of the Qualification and were doing the same job as other teachers.

This year new recruits with letter of completion pending graduation are being paid \$12,360 instead of the normal Diploma and Degree salaries. The Union is also pursuing this case of unfair labour practice.

#### 6. Transfer on Promotion

No transfer allowance is paid to promotees. This is unprecedented and most unjustifiable. The Ministry has been asked to review its unfair decision.

### 7. Open Merit Based Recruitment and Selection

The first lot of post have been processed as per the OMRS. The outcomes have revealed serious anomalies. Numerous complaints have been received from members who felt they were better meritorious than the promotee but had not been considered.

The Union wrote to the Minister for Public Service raising concern on OMRS. The Minister for Economy has agreed to convene a meeting with the Teacher unions and MOE to examine the short-comings and find solutions.

#### **REMINDERS - FTU**

- 1. For Medical Insurance, Office must be notified if there is a change in status (marriage) and children's name added if there is any addition in the family.
- 2. Referral letter must be obtained from FTU doctor for any tests or specialists treatment.
- 3. MABS claim must be made within a month
- 4. MABS benefits cover children up to the age 25 if they are schooling. Those who are studying away from home



- can apply for an additional card. The MABS card and student ID card must be presented to the Doctor.
- 5. Medical reports must be provided by all applicants who have been in the teaching service for more than 12 months.
- 6. If the spouse is a teacher, then both have to be members to get Insurance and MABS benefit. If not, only the member will receive the benefits. Family Insurance Premium is paid by one spouse.
- 7. Under FTU Medical Insurance Cover, all post surgery reviews are to be done at the nearest Public Hospital. Any cost incurred at the Public Hospital will be reimbursed.
- 8. Membership Teachers on Contract.

  Members must check with MOE to see that their Union and Medical deductions continue when contracts are renewed.

#### **REMINDERS - FTU-CTCL**

- 1. FTU/CTCL Offices must be notified for any change in address.
- 2. Latest Salary Slip showing all deductions must be attached to the Loan Form. Your Loan will not be processed if salary slip is not attached.
- 3. Members resigning from service can leave their shares in CTCL and receive the dividend only. However, hideaway shares will have to be withdrawn.
- 4. The office has identified some members of FTU CTCL who are non members of FTU. They have been notified to join FTU immediately to receive any further benefit from FTU CTCL.
