The National Council meeting, held on December 11, filled the vacant post created by Bro. Vishal Raj Goundar. We congratulate Ba Branch Rep, Bro. Nakul Deo Barman, for his appointment to the position of National Executive Committee Member. Bro. Nakul Deo is a seasoned and experienced unionist, having served Nadi and Ba branches in various positions. Bro. Nakul Deo served as the President of the Fiji Trades Union Congress Youth Wing. ## INDUSTRIAL RELATIONS QUALIFICATION UPGRADES GRADUATE SALARY PLACEMENT

The matter of qualification upgrades has been an ongoing subject of representation by the union. Following sustained negotiations, FTU is pleased to confirm that teachers who have attained graduate-level qualifications, including STTC, IDTT, and DTT will now be remunerated at Band F, Step 3, effective after a lapse of two years.

Teachers who submitted their verified academic credentials to the Ministry on or before April 30 of the current year will receive the adjustment in the present financial year. Submissions made thereafter will be processed in the subsequent fiscal year. This outcome is a significant achievement resulting from persistent engagement with the Ministry and is in line with the principles of merit-based remuneration.

## RECOGNITION OF STTC, DTT, AND IDTT QUALIFICATIONS

Members will recall that in mid-September 2021, these qualifications were deregistered by the Ministry, causing substantial hardship to affected teachers. Upon the Union Secretariat assuming office in June 2023, active efforts were initiated with the Fiji Teachers Registration Authority (FTRA) and the Fiji Higher Education Commission (FHEC).

After extensive consultations and formal submissions, FTU successfully secured the reinstatement of recognition for these qualifications. This milestone ensures that teachers holding these credentials are now eligible for graduate-level salary placement, restoring their rightful professional status.

#### REINSTATEMENT OF TEACHERS AFFECTED BY THE "NO JAB, NO JOB" POLICY

Teachers whose employment was terminated under the former Government's COVID-19 vaccination mandate were permitted to rejoin the service following the formation of the Coalition Government in 2022. Those reinstated were placed on a six-month probationary period, after which their employment was to be regularized, and their salary aligned with their qualifications.

This year's salary upgrade exercise formally caters for these reinstated teachers. FTU emphasizes that the process must uphold principles of natural justice, non-discrimination, and constitutional rights. Members who meet the criteria but have not received the appropriate salary adjustment are advised to promptly contact the Secretariat for immediate intervention.

#### **EDUCATORS PROTECTION POLICY**

At the 2023 FTU Annual General Meeting in Labasa, members unanimously endorsed the development of an Educators Protection Policy. Since then, the Secretariat has consistently pursued this matter with the Ministry of Education, including representation in two national budget submissions.

A draft version of the policy is now completed, and consultative meetings are underway to refine its provisions. FTU remains committed to ensuring that the final policy provides a robust framework for safeguarding educators' rights, safety, and professional integrity in accordance with the law.

#### **REVIEW OF EDUCATION POLICIES**

FTU, in collaboration with the Fijian Teachers Association (FTA), is actively participating in the Ministry-led review of about 18 education policies. This collaborative process represents a significant breakthrough, reflecting the Ministry's willingness to partner with the unions to strengthen teachers' terms and conditions of service. These reviews will modernize policy frameworks, enhance clarity, and ensure alignment with current educational standards and constitutional protections.

#### **TRANSFERS**

The Secretariat will shortly be meeting with the Director of Human Resources and the Ministry's HR Team to review transfer applications submitted for the 2026 academic year. FTU will continue to advocate for transparent, equitable, and family-friendly transfer processes that respect teachers' welfare and professional obligations.

## SCHOOL TERM DATES AND EXAMINATION TIMETABLE, 2026

FTU was a key participant in the multistakeholder consultation regarding the 2026 school calendar and national examination timetable. After careful consideration of multiple factors, including academic, operational, and student well-being, the schedule has been finalized.

At FTU's request, the Examinations and Assessment Unit has agreed to increase the number of Year 8 markers to ensure results are released by Week 11 of Term 3, thereby supporting timely enrolment in secondary schools. The Year 8 Annual Examination will now be conducted alongside Years 4 to 7 in Week 9 or Week 10, with schools retaining discretion on preferred timing. The standard LANA examinations for Years 5 and 7 will be discontinued from next year.

### EXTERNAL EXAMINATION PAPER LEAKAGE

FTU expresses deep concern at the reported leakage of the Year 12 external examination papers. The breach appears to have arisen from a failure to follow the established Standard

Operating Procedures governing the secure handling of examination materials.

The union firmly condemns any unethical or unprofessional conduct that compromises the integrity of national assessments. FTU calls on the Ministry to conduct a thorough and transparent investigation and ensure that all individuals responsible are held accountable in accordance with law and due process.

#### BACK-TO-SCHOOL ASSISTANCE (BTSA) – IMPROPER LEVY REQUESTS

It has come to the union's attention that some Heads of Schools have been imposing unauthorized levies when verifying and signing BTSA forms. Such actions are contrary to Ministry directives, violate principles of public service ethics, and impose undue financial burden on families. FTU unequivocally denounces these practices and advises its members to desist from participating in any such conduct.

#### **CORPORAL PUNISHMENT**

Education Minister Honourable Aseri Radrodro made it clear that corporal punishment will not be allowed in Fiji's schools, saying the Ministry must follow the Constitution and international laws that protect children from violence. Speaking at the 27th Attorney-General's Conference in Nadi, Hon. Radrodro said the issue was not just about policy but about legal responsibility. Hon. Radrodro revealed that the number of recorded corporal punishment cases in schools has fluctuated in recent years.

Between 2018 and 2025, the Ministry of Education recorded a peak of 84 cases in 2022 and a low of 7 cases in 2020, with most incidents involving students being hit with hands or a cane. He also confirmed that between January and October this year, 11 corporal punishment cases were reported through the Divisional Counselling Hubs and the Student Support Services and Advisory Council.

Members must note that the 2003 Naushad Ali court ruling made corporal punishment unlawful, and the 2013 Constitution guarantees every child the right to be free from violence. Fiji's commitments under the Convention on the Rights of the Child, which prohibit the use of physical punishment, must be adhered to.

The Minister outlined several measures being rolled out to support schools, including counselling hubs in all four divisions, a requirement in the draft Education Bill for every school to engage a trained counsellor, the re-establishment of school chaplains, and a review of the Behavioral Management Policy to introduce guidelines on positive discipline.

### FTU'S STAND- SAY NO TO CORPORAL PUNISHMENT.

#### THE WAY FORWARD

The matters outlined above reflect the ongoing commitment of the Fiji Teachers Union to defend the rights, entitlements, and professional integrity of all its members. The Secretariat remains fully dedicated to ensuring that all actions undertaken are consistent with the Constitution of Fiji, relevant statutes, collective agreements, and the principles of fairness, accountability, and good governance.

In addition, the Secretariat continues to be heavily involved in pursuing improved outcomes for teachers through structured and constructive negotiations with the Ministry. We acknowledge and appreciate that the Ministry has shown a high level of cooperation and openness in addressing issues raised by the union.

This positive and collaborative environment makes it even more important for the union to remain focused on its core mandate to advocate, to safeguard, and to advance the welfare of all teachers. Given that the Ministry is responsive and attentive to our representations, the union leadership will continue to present concerns directly, consistently, and professionally to ensure timely and favourable resolutions. FTU affirms that no case brought before the union will be abandoned; every matter will be pursued diligently and persistently until the desired goals are fully achieved.

## ANNUAL CONFERENCE OFFICIAL OPENING

During the 95th Annual Conference at Cuvu College in Sigatoka, we gathered as a united force. For the first time in the union's history, we had the official opening at the Shangri-La Fijian Resort a day prior to the Annual General Meeting. The official opening marked a record attendance.

FTU is grateful to the major sponsor Bred Bank for injecting the much-needed finance to ensure that the official opening was done at a splendid venue like the Shangri-La Fijian. FTU extends its deepest appreciation to all members for their unwavering support throughout the event.

#### **SPORTS MEET**

Sporting events have always brought an added level of excitement and energy to the AGM and Annual Conference. This year was no exception, as the games drew a large crowd to Lawaqa Park.

The soccer competition was fiercely contested, with Nadi emerging victorious over Lautoka. In a surprising turn of events, the Rewa women's volleyball team upset Suva to claim the title for the first time. Nadroga secured the netball championship by defeating Rewa, while the men from Suva triumphed over Bua in the men's volleyball final. It was the first time that Bua played in the final of the men's volleyball competition.

The awards were given as follows: football-Shahil Naresh (Nadi), women's volleyball-Tavaita Daunakamakama (Rewa), netball-Karishma Dass (Nadroga) and men's volleyball-Wayne Fisher (Suva).

The best dressed teams were: football- Labasa, women's volleyball- Nasinu, netball- Ba and men's volleyball- Nasinu.

#### THANKS, AND APPRECIATION

The host branch- Nadroga deserves credit for hosting the 95th AGM and Annual Conference. The Executives pulled the loose ends, got a 'spirited' team, and organized the four-day Conference and the Pre-conference and Postconference meeting. It was pleasing to note the support from FTU stalwarts, including those who have retired from FTU. The commitment of the FTU leadership to stand and defend the collective and individual rights of the membership remains steadfast and has been praised by many. The membership at large is complimented for the wonderful support that was rendered in Nadroga. Special thanks are due to the Nadroga branch Executives, led by Bros. Mesh Chand, Roop Chand and Subramani Krishna for their exceptional efforts in organizing what was a remarkable conference, marked by great

sportsmanship, impressive attendance and the first of its kind cultural night and breakout sessions.

#### **2026 ANNUAL CONFERENCE**

The Fiji Teachers Union Annual Conference will take place at Xavier College from Tuesday May 5 to Friday May 8, 2026. The theme for the Annual Conference is 'Teachers at the heart, driving progress from the start'. Members can start compiling their articles for the journal. Branches must start preparations early so that there is no last-minute disappointment in terms of participation as a delegate and in sports.

#### **BRANCH VISITS/ CLUSTER MEETINGS**

The General Secretary continued to visit schools and districts and addressed cluster meetings to enlighten members on current issues as well as maintain connectivity. School Reps and branch Executives worked together to ensure that these cluster meetings were a success in terms of attendance of members.

#### **FTU JOURNAL**

The Publicity Committee, comprising of Bros Brij Singh, Rajnesh Lingam, Pranesh Kumar, and Sis Urmila Singh, worked tirelessly to complete the journal. We apologize for any shortcomings.

#### DIVISIONAL WORKSHOPS

To boost dissemination of information and ensure members were on par with union literature, four capacity building sessions were held as follows: Southern Division for Rewa, Suva, Navua and Nasinu members at FTU HO on Wednesday July 9; North Western Division for Lautoka, Nadi and Nadroga members at Nadi Airport School on Saturday August 23; South Western Division for Ba, Tavua and Rakiraki members at Tavua College on Saturday October 4; and Northern Division for Savusavu, Bua, Labasa and Taveuni members at Labasa College on Saturday November 8. We were impressed with the turnout, although there should have been more members attending the session. The topics focused on: MABS, the insurance medical empowering women, the role of principal officers, industrial relations, trade union renewal and communication. We urge greater participation from branches when we organise capacity building sessions.

## GO PUBLIC! FUND EDUCATION CAMPAIGN STRATEGIC PLANNING MEETING

The Go Public! Fund Education Campaign Strategic Planning meeting was held at the Tanoa Skylodge, Nadi, from August 4 to August 6, which was organized and facilitated by the Education International and Council of Pacific Education.

The objectives of the workshop were to: initiate advocacy for increased public funding to education, recognize the transformative power of education, and prioritize and adequately fund public education systems to ensure quality education is accessible to all children globally.

The strategic meeting brought together EI member organizations in the five selected countries in the Pacific sub-region to: understand the current landscape to assess critical issues such as teacher shortages, working conditions, workload, mental health, and education financing in their respective countries. leverage the UN panel recommendations, explore practical strategies to address these challenges, guided by the recommendations of the UN high-level panel, strengthen sub-regional and national advocacy, align with the Go Public! Fund Education! Campaign and develop coordinated advocacy plans at national and sub-regional levels. The workshop was attended by the General Secretary, General Treasurer, Sis. Urmila Singh and Sis. Karishma Dass (Nadroga branch).

#### **COPE WOMEN'S TRIENNIAL**

The 40th Council of Pacific Education Women's Triennial was attended by Sis. Salome Vakabuto (Rewa branch) and Sis Subashni Kumar (Lautoka branch) at the Tanoa Skylodge from October 30 to 31. The theme for the Triennial was "Empowering Women, Funding Futures: Go Public for Equity in Education". The aim was to empower Pacific women educators and union leaders to promote gender equity, digital inclusion and public

investment in a culturally responsive education system.

#### **COPE- YOUTH TRIENNIAL**

The Council of Pacific Education Triennial took place at the Tanoa Skylodge from October 27 to 29. Bro. Ronal Kumar (Rewa branch) and Sis. Archana Vandhana (Nasinu branch) represented FTU. The youths were engaged in discussions on the importance of teacher unions in promoting fair working conditions and quality education. The session also highlighted the need for a youth wing in every teacher union, to ensure youth voices are represented in decision making. Both Bro. Ronal Kumar and Sis. Vandhana Archana made valuable contributions during the robust session.

#### **COPE-TRIENNIAL**

The Council of Pacific Education Triennial was attended by the youth and women reps and the General Secretary and Vice President, Bro. Pranesh Sharma after the conclusion of the Youth and Women's Triennial at the Skylodge.

#### ASIA-PACIFIC REGIONAL CONFERENCE ON ACADEMIC FREEDOM AND DEMOCRACY

This was held in Kochi, India from October 15 to 17. It was attended by the National President, General Secretary, and Vice- President Sis Urmila Singh.

## AUSTRALIAN EDUCATION UNION (AEU) CONFERENCE

This was attended by Bro. Shonal Surendra Butturu (Nasinu branch) at Brisbane State High School from November 22 to 23. The Conference brought together educators, union leaders, policy specialists, and international delegates to discuss key developments in education, teacher welfare, and union advocacy across the region.

It provided an important platform for strengthening professional partnerships and gaining insights relevant to Fiji's educational sector. The primary objective of attending the Conference was to strengthen FTU's collaboration with AEU. Bro. Shonal Butturu gained a lot of knowledge from the sessions.

#### EI GLOBAL CONFERENCE

The Education International Global Conference on Artificial Intelligence was held in Brussels from December 4 to 5. It brought together over 200 union leaders and experts to examine how AI is reshaping education. Participants were warned that while AI promises efficiency, it often increases teacher workload, undermines professional autonomy, and deepens digital and equity divides. The speakers emphasized the risks of commercialization, data colonialism, bias, and reduced teacher roles in AI-driven reforms.

Unions called for a human-centred approach where AI supports and not replaces teachers. The key priorities included strong regulation, data protection, public investment, critical AI literacy, and meaningful social dialogue. The Conference highlighted the need for global solidarity to ensure AI strengthens democratic, equitable public education.

#### PINKTOBER

This was observed at FTU HQ on October 23. FTU contributed \$500.00 each towards WOWS Kids and the Fiji Cancer Society, respectively. Members made personal cash contributions.

#### FHTA/ FPA CONFERENCE 2025

The General Secretary was honored to attend the official opening of the Fiji Head Teachers Association and Fiji Principals Association at Sheraton Denarau, an event graciously hosted by the Suva Head Teachers Association and Nausori Principals Association, respectively. It was, without a doubt, a grand and memorable conference. On behalf of the membership, the Secretariat extends heartfelt thanks to the executives of the FHTA and FPA for organizing such a splendid event.

#### **NORTHERN ZONAL SPORTS**

The Headquarters extends its sincere thanks and appreciation to Bua branch for successfully hosting this year's Northern Zonal Sports Meet. Labasa emerged victorious in football and men's volleyball, while Bua triumphed in netball, and women's volleyball title. Trophies were presented to both winners and runners-up in recognition of their outstanding performances.

Cash prizes were also awarded to the best players. Members also enjoyed the refreshments, with tea and lunch provided during the event. HQ salutes Taveuni for their participation. After a robust round of discussion, the NE decided to increase the premium and this motion was taken to the AGM in Nadroga. The AGM endorsed the approval based on the rising costs of medical treatment and costs associated with airfares.
